## Pro Bowl VIP Sweepstakes

## Official Rules

## No Purchase Necessary to Enter or Win.

1. Eligibility: The Pro Bowl VIP Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older as of the date of entry. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. 4. Winner Selection: One (1) Grand Prize winner will be selected from amongst all eligible entries received throughout the Promotion Period on or about $2 / 27 / 21$. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. Potential winner will be notified via email at the email address provided on his/her entry. If the potential winner is unresponsive by the designated deadline, no further attempt to contact such individual will be made and that individual will be disqualified and an alternate potential winner may be chosen, time permitting and at Sponsor's sole discretion. Odds of winning depend upon the total number of eligible entries received. If winner is at least eighteen (18) but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein.
5. One (1) Grand Prize: The Grand Prize winner will receive a 4-day/3-night trip for winner and one (1) guest to attend the 2022 NFL Pro Bowl ("Pro Bowl"). Trip includes: i) round trip coach air transportation from a major gateway airport nearest winner's residence to a destination determined by Sponsor ; ii) one (1) standard hotel accommodation (one (1) room, double occupancy) for three (3) nights; iii) round trip ground transportation to and from the game; and iv) two (2) tickets to Pro Bowl. Approximate Retail Value ("ARV"): $\$ 2,000$. Actual prize value may vary based upon winner's residential location. Any difference between stated value and actual value will not be awarded. If the winner resides within a one hundred (100) mile radius of the destination location, ground transportation may be provided in lieu of air transportation at Sponsor's sole discretion, and no compensation or substitution will be provided for difference in prize value. Trip must be taken on dates designated by Sponsor or prize will be forfeited in its entirety and, at Sponsor's discretion, awarded to a runner-up.
